

HORSE INFORMATION:

- **All horses delivered to GFA Montpezat - Scott Allman Arabians must have a Health certificate & a valid passport. All horses must be current on all influenza vaccinations. Influenza vaccinations cannot be more than 6 months apart according to EFI and ECAHO regulations.**
- **The first month board and training fees are due upon arrival of horse. Payments will be accepted in cash or by credit card or check.**

Date of arrival:

While horse is in training, **GFA Montpezat - Scott Allman Arabians** provide the following:

BOARDING HORSES:

- daily cleaning of the stables and fresh bedding
- pasture daily when weather allows
- Daily grooming
- Worming every 2 months (additional charge)
- Blacksmith every 4 weeks (additional charge)
- Veterinary will be called out if trainer thinks it is necessary for the well being of client horse. All fees incurred are for the horse owner.
- bath 1 day a week
- **GFA Montpezat - Scott Allman Arabians** agrees to do their utmost to professionally care for the client horse per the clauses in this contract.

TRAINING HORSES:

- Daily feeding in the mornings, mid day and evening. Feeding includes hay and grain. Vitamins will be given with an additional fee of Euro. 10.00 per month
- Pasture minimum 2 days a week when weather allows.

- Show training 3-4 days a week or at trainers discretion.
- Conditioning daily.
- Daily grooming.
- Bath daily after the training program.
- Maintenance clipping
- Blacksmith every 4-6 weeks (additional charge).
- Veterinary will be called out if trainer thinks it is necessary for the well being of client horse. All fees incurred are for the horse owner.
- Body clipping for shows and conditioning when necessary (additional charge).
- Photo shoots for marketing and promotion (additional charge).

CLAUSES PAYMENTS:

- The first month payment is due upon the arrival of the horse.
- **GFA Montpezat - Scott Allman Arabians** will invoice at the end of every month for the upcoming month.
- It is agreed upon that all fees will be invoiced and due payable within 7 days of the date of invoice by check, bank transfer or visa card.

- **Client must leave with GFA Montpezat - Scott Allman Arabians a valid visa card number for debiting in the event of delinquent payments or for your convenience. For those who want to pay by Visa card, the debiting date will be noted on your invoice. All clients will be notified before the debit.**
- **If payments are not received within the 7 days of the date of the invoice, payment will be debited from clients Visa Card.**

CLAUSES INSURANCE AND LIABILITY RELEASE:

- It is agreed upon that **GFA Montpezat - Scott Allman Arabians** and their employees are released of all liability of client horse. **GFA Montpezat - Scott Allman Arabians** and their employees cannot be held responsible for sickness or death of client horse.
- Horse owner agrees to carry a full coverage insurance policy of their horse while in training or board at **GFA Montpezat - Scott Allman Arabians**. If owner does not have a full coverage insurance policy on their horse while at **GFA Montpezat - Scott Allman Arabians**, Horse owner agrees that **GFA Montpezat - Scott Allman Arabians** and their employees are released 100% of all liability and cannot be held responsible for death or illness or injuries to horse.

SHOWS:

- **GFA Montpezat - Scott Allman Arabians** agrees to enter horses in training for the shows by the deadlines.

- **An administration fee of Euros. 10.00 will be invoiced to client for each entry. If client doesn't agree with this clause, client will then enter his horses himself for all show to be attended.**
- **GFA Montpezat - Scott Allman Arabians** will send to client the data of the registration for the shows including banking details of organization
- Client is responsible for all entry fees of shows attended.
- **GFA Montpezat - Scott Allman Arabians will not pay entry fees for any client. If the entry fees are not paid by client before the deadline, the entered horse will not depart for the show. No refunds of any kind will be considered.**
- In the event trainer or handler (**Scott Allman**) has more than one horse in a class at any show, Handler can chose which horse he leads in the first round.
- In the event handler has more than one horse in the front row of a championship class, Handler takes the horse he feels has the best chance to win or the horse with the most points in type.
- If there are two horses in the front row **Scott Allman** will present the horse with the highest points in type. In this situation **Scott Allman Arabians** will organize a competent handler for the other horses in the championship class.

CONCLUSION:

- This concludes this contract any and all changes must be put to writing and included in this contract. No verbal agreements will be accepted or considered.
- The undersigned agrees to all terms and conditions of this contract.
- All Arbitrations or legal proceedings will take place in the country of France.
